DEPUTYSHIP FAQs

Can you apply for appointment as Appointee whilst awaiting the Deputy Order?

Yes, we can arrange an appointee whilst preparing the application for deputyship.

Can you deal with cases that involve the complexity of a property?

Yes. This is a common reason for referrals, including orders for sale, equity release, rentals and cases involving third party occupants.

Do you take on new deputyship cases and take over existing ones?

Yes, we are happy to do both.

On instruction, will you liaise with third parties for information and can you arrange for COP3?

Yes - after instruction we can obtain information from the LA, speak to third parties or facilitate a property search. We can arrange for a COP3 (Assessment of Capacity) to be completed, if the LA is unable to. Note: this may require additional time/expense.

OTHER SERVICES FOR LAS

We have a dedicated private client team led by a Senior Partner who is also an experienced Professional Deputy working closely with Local Authorities. We have tailored our related legal services to support LAs.

1. Administering Estates - our private client team can help ease the financial strains of care debt that many local authorities have due to the impact of large numbers of deceased estates with nobody actively administering them.

We work in tandem with a number of genealogists and can help get these estates administered and local authorities repaid for the care fees they have funded as quickly as possible.

2. Wills - many deputyship clients may still have testamentary capacity (capacity to make a Will) despite requiring the involvement of Attorneys or Deputies with their financial affairs. There may, therefore, be a window of opportunity to actively evaluate prospects to make a Will. This can then simplify the estate administration process and ensure that debts (including

LA care fees) can be more swiftly repaid.

Even for Clients requiring a Deputy or Attorney for their finances but without testamentary capacity, our experienced private client team can assist with evaluating whether applying for a Statutory Will is in the client's best interests, which again offers the same benefits to local authorities for swift repayment of debt.

- 3. Lasting Powers of Attorney (LPAs) another window of opportunity is where a capacitated client can be supported to make an LPA. This can avoid the potential logjam of waiting until a Deputy becomes appointed if somebody loses capacity at a later time. We have a number of cases where we have helped a client who, otherwise, had no one to support them.
- **4. Trusts** we are experienced in creating and administering a variety of trusts that have inherent complexities, but equally benefits, when applied carefully to individual circumstances. Again, there may be powers and entitlements that can be used to fund the clients care or care debt that could be explored.
